PUBLIC USE POLICY

HELP NASH FARM PRESERVE, PROTECT AND VISUALLY REFLECT THE AGRICULTURAL HERITAGE OF THE GRAPE VINE PRAIRIE BY FOLLOWING THIS USAGE POLICY.

- 1. Nash Farm grounds are open during the following schedule, unless otherwise posted:**
Memorial Day to Labor Day – Monday through Friday, from 10:00 a.m. to 8:00 p.m.; Saturday and Sunday, 9:00 a.m. to 5:00 p.m.
Labor Day to Memorial Day – Monday through Sunday, from 9:00 a.m. to 5:00 p.m.
Closed on all City holidays, as well as, two weeks in February set aside for annual repair.
Trespassing is prohibited by City Ordinance No. Ch. 15 Sec. 15-13.
2. Self-guided tours of the grounds are available during regular operating hours and guided tours are available by reservation.
3. Historic structures are open during events and interpretive programs, unless otherwise posted.
4. Grounds and Pole Barn Pavilion are available for rent and require a rental permit.
5. Parking is permitted on the farm-side of Homestead Lane and the Botanical Gardens on Ball Street.
6. Livestock may only be fed from feed dispensers provided on-site.
7. All photo shoots must have a permit, along with an up-to-date photographer membership with the Grapevine Heritage Foundation.
8. Historic resources, including artifacts and historic structures, may not be disturbed or removed.
9. Strollers, food and beverages are prohibited in historic structures, but permitted on grounds and pavilion.
10. No pets are permitted, with the exception of Service and Guide Dogs properly attired in service vest.
11. Solicitation is prohibited by City Ordinance No. 2003-14. Please refrain from using profanity, disturbing other visitors, disrupting equipment, crops or livestock; tobacco and E-cigarette products within structures are prohibited.
12. Public consumption of alcohol is prohibited, unless permitted by rental. Littering and glass containers are prohibited at Nash Farm.
13. Weapons of any kind are prohibited. The use of fires or any flammable materials, projectiles or fireworks are prohibited, unless permitted by rental.
14. Bicycles, skateboards, in-line skates, roller skates, golfing, air soft guns and other activities of a non-educational nature are prohibited.
15. Nash Farm, its staff, boards and committees are not liable for personal injury.
16. Warning: Under Texas Law (Chapter 87, Civil Practice and Remedies Code), a farm animal professional is not liable for an injury to or the death of a participant in farm animal activities resulting from the inherent risks of farm animal activities.
